Privacy Notice for Pupils - How we use pupil information

Why do we collect and use pupil information?

We collect and use pupil information under the lawful basis of Legal Obligation (as set out in Education Act 1996, Children Act 2004, SEND Regulations 2014 and the Education Regulations 2005). Also, under the lawful basis of Official Duties as set out in the Education Acts (GDPR May 2018). The school is also required by law to collect Special Data such as racial or ethnic origin as set out in Article 9 of the GDPR May 2018.

We use the pupil data:

- to support pupil learning
- to monitor and report on pupil progress
- to provide appropriate pastoral care
- to assess the quality of our services
- to comply with the law regarding data sharing

The categories of pupil information that we collect, hold and share include:

- Personal information (such as name, unique pupil number and address)
- Characteristics (eg ethnicity, language, nationality, country of birth and free school meal eligibility)
- Attendance information (eg sessions attended, number of absences and absence reasons)
- Assessment information
- Mode of travel
- Relevant medical, special educational needs and behavioural information
- Child protection and safeguarding information

Collecting pupil information

Whilst the majority of pupil information you provide to us is mandatory, some of it is provided to us on a voluntary basis. In order to comply with the General Data Protection Regulation, we will inform you whether you are required to provide certain pupil information to us or if you have a choice in this.

Storing pupil data

We hold pupil data for and in accordance with our Records Retention Policy which can be viewed on our school website. This is based on the IRMS Information Management Toolkit for Schools. When a child leaves the school, electronic files are passed to the Local Authority and to the receiving schools. Any child protection, special educational needs records are also passed to the receiving school.

Who do we share pupil information with?

We routinely share pupil information with:

- schools that the pupil's attend after leaving us
- our local authority
- the Department for Education (DfE)
- Health professionals (school nurse/NHS, education psychologist, speech & language,



occupational health, CAMHS)

- SEND professionals
- Tucasi (on-line communication and payment system)
- Learning Ladders (our assessment system)
- E4Education, our school website provider
- Micro Librarian (our library software)
- 3PLearning (providers of Spellodrome & Mathletics)
- Purple Mash (curriculum support software)
- Education City (curriculum support software)
- Providers of residential accommodation & activities (eg PGL)
- Any other body with whom the school may be required to share data

Why we share pupil information

We do not share information about our pupils with anyone without consent unless the law and our policies allow us to do so.

We share pupils' data with the Department for Education (DfE) on a statutory basis. This data sharing underpins school funding and educational attainment policy and monitoring.

We are required to share information about our pupils with our local authority (LA) and the Department for Education (DfE) under section 3 of The Education (Information About Individual Pupils) (England) Regulations 2013.

Data collection requirements:

The National Pupil Database (NPD)

The NPD is owned and managed by the Department for Education and contains information about pupils in schools in England. It provides invaluable evidence on educational performance to inform independent research, as well as studies commissioned by the Department. It is held in electronic format for statistical purposes. This information is securely collected from a range of sources including schools, local authorities and awarding bodies.

We are required by law, to provide information about our pupils to the DfE as part of statutory data collections such as the school census and early years' census. Some of this information is then stored in the NPD. The law that allows this is the Education (Information About Individual Pupils) (England) Regulations 2013.

The department may share information about our pupils from the NPD with third parties who promote the education or well-being of children in England by:



- conducting research or analysis
- producing statistics
- providing information, advice or guidance

The Department has robust processes in place to ensure the confidentiality of our data is maintained and there are stringent controls in place regarding access and use of the data. Decisions on whether DfE releases data to third parties are subject to a strict approval process and based on a detailed assessment of:

- who is requesting the data
- the purpose for which it is required
- the level and sensitivity of data requested: and
- the arrangements in place to store and handle the data

To be granted access to pupil information, organisations must comply with strict terms and conditions covering the confidentiality and handling of the data, security arrangements and retention and use of the data.

Requesting access to your personal data

Under data protection legislation, parents and pupils have the right to request access to information about them that we hold. To make a request for your personal information, or be given access to your child's educational record, contact the school office.

You also have the right to:

- object to processing of personal data that is likely to cause, or is causing, damage or distress
- prevent processing for the purpose of direct marketing
- object to decisions being taken by automated means
- in certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed
- claim compensation for damages caused by a breach of the Data Protection regulations
